THC (Terminal Handling Charges)	\$ 29.55 Per CBM	Terminal handling charges (THC) are charges collected by shipping lines to recover from the shippers the cost of paying the container terminals for the loading or unloading of the containers and other related costs borne by the shipping lines at the port of shipment or destination..
Ocean Sea Freight	\$ 30.00 to \$ 170.00 Per CBM	Ocean Freight or Sea Freight means shipping line vessel cargo transport cost through shipping liner vessel. The cargo container that you are shipping will be transported from origin country sea port to the destination country sea port by sea vessel. The sea freight rate will vary from country to country.
Port Transport	\$ 8.00 Per CBM	Port Transport is cost of shipment cargo transport from supplier location to Origin port to load shipment on sea vessel after custom clearing.

Shipment Documentation Cost Details (applicable Per Shipment)

Shipment Documentation	Fee Amt (in USD)	Explanation in detail
Bill of Lading	\$29.00	A bill of lading (sometimes referred to as a BOL , or B/L) is a document issued by a sea vessel carrier to a shipper, acknowledging that specified goods have been received on board as cargo for conveyance to a named place for delivery to the consignee who is usually identified. B/L is issued in a set of three signed originals of which must be presented to claim the goods upon which the others become void
Certificate of Origin	\$8.51	A Certificate of Origin (often abbreviated to CO or COO) is a document used in international trade. It traditionally states from what country the shipped goods made and originate.
GSP-1 for Europe	\$12.50	GSP (Generalized System of Preferences) Form A CO. The CO is primarily important for classifying the goods in the customs regulations of the importing country, thus defining how much duty shall be paid or if duty taxes exempted.
Advance Cargo Declaration	\$25.00	As per U. S. Customs Security Regulations on Imports into US all shippers file details Cargo Data Elements notified to US Customs with "24-HOUR ADVANCE MANIFEST FILING RULE" effective from 02nd December, 2002.
Shipment Fumigation	\$48.00	The ISPM15 Fumigation Certificate, also referred to as a 'pest control certificate' is the proof that wooden packing and materials used in international sea freight shipping have been fumigated or sterilized prior shipping. Fumigation certificates usually contain details such as purpose of treatment, the articles in question, temperature range used, chemicals and concentration used, etc.
Export Documentations Bank Forex Fee	\$48.00	Bank Forex recd. Fee for F.I.R.C. foreign inwards remittance certificate and documents for export shipment like SDF Form-A for shipping bill and custom clearing including service tax for preparing various shipping documents.
Shipping Documents thru DHL	\$34.00	Cost of DHL / FedEx Express to send original shipping documents to buyer home address to get release shipment thru these documents.
CHA Custom Clearing Fee	\$34.00	CHA Custom House Agent Fee for filing Export Shipment Invoice and Packing List and shipping bill, SDF Form-A and custom clearing and physical inspection of shipment before container stuffing.
Shipping Agent Fee	\$41.00	Shipping agent fee for shipping arrangements including Container stuffing and loading of shipment to sea vessel and issue Bill of Lading.
